Dr. Konkle-Parker received her family nurse practitioner training at UMMC, and obtained a PhD in Nursing with an emphasis in behavioral research, also at UMMC. She has worked with people living with HIV since 1996, and has contributed significantly to the clinical and research infrastructure related to HIV at UMMC, through her receipt of federal funds to support provision of HIV care to vulnerable populations, and for conducting interventional and observational research to improve the clinical outcomes of people living with HIV and to understand the impact of HIV as people age. She has published more than 40 peer-reviewed articles, and has done more than 60 presentations, and has mentored many students and junior faculty regarding the research process.
