Match Day 2020 marches on, despite global COVID-19 pandemic

In the background of all that is happening because of the COVID-19 pandemic, normal milestones have still been passed.

March is generally a time of celebration with the beginning of spring, St. Patrick's Day, the NCAA

Jackson-Williams basketball finals and Match Day. This year, everything changed.

We did, however, have Match Day.

The students organized a virtual Match Day to celebrate this major milestone for themselves and their classmates.

From a national perspective this year, the match was destined to be different. This was the first year for a single match for all allopathic (M.D.) and osteopathic (D.O.) students. This single match occurred after the development of a single accreditation system with the ACGME as the primary accrediting body for graduate medical education programs across the nation.

Because of this change, this was the largest match for the National Resident Matching Program.

The Class of 2020 at UMMC had a great match, even though this has been a tough last two months to celebrate. The class members matched into 22 different specialties. Of the 145 students in the class, 81 matched in a primary care specialty (PED, FM, IM, Med-Peds, Ob-Gyn) and 52 will stay in Mississippi for at least their first year of residency training.

The residency programs here at UMMC did well and all have their full complement of interns scheduled to begin in July.

Our M4 students and our program staff are looking forward with anticipation and hope towards this next phase. However, there is much angst for both with the upcoming usual changes and, now, the addition of a training environment in the midst of a pandemic.

Medical education must continue in face of worldwide pandemic

The effects of the COVID-19 pandemic have touched each of our missions at UMMC.

The clinical mission is rightly our chief priority as we work to ensure enough capacity to care for the many Mississippians whose lives are at risk from the disease. At the same time, however, the educational programs must go forward so we can meet the future needs of our state in

the post-COVID-19 world.

A dedicated group of faculty, administrators and students in the School of Medicine has been working behind the scenes to ensure that medical education continues, while also ensuring the safety of our students, staff, faculty and patients.

With the guidance of the American Association of Medical Colleges and the Liaison Committee on Medical Education, the following decisions have been made to enable the continued progression of our students through their training:

- First- and second-year courses have been streamlined to ensure that all critical content is presented in the most timeefficient manner. All educational sessions will be online, allowing students to learn while maximizing social distancing. Examinations will be administered remotely with video monitoring software to ensure test security. Students completing the M2 year will still take their Step 1 examinations.
- For the remainder of this academic year, all third-year courses will be completed online. The school has managed to procure

free or heavily discounted access to a variety of educational and assessment resources that will allow students to participate remotely in patient care activities while also making use of simulation to ensure clinical skills and reasoning are taught and assessed. To further ease the burden on clinical services, there will be no further third-year electives; instead, each M3 student will be enrolled in an independent study elective, allowing him or her to prepare for the Step 2 CK examination while receiving academic credit.

• We have received guidance from the LCME allowing us to waive elective requirements for the M4 students. With approval from the curriculum committee, senior students with remaining core requirements will be enrolled in one of several two-week online courses that will fulfill their remaining requirements. These changes will ultimately allow us to graduate our senior students earlier than originally anticipated, potentially allowing some of them to join the labor pool earlier than anticipated.

We give a huge "thank you" to the faculty members and administrators who have engaged in this important work while also fulfilling their clinical responsibilities. There will come a day when we no longer have to worry about COVID-19, and our programs in the School of Medicine will still be going strong.
